



## **Competition Terms and Conditions**

### **1. Promoter**

The Promoter of all in-store competitions is Aheers Supermarket (“Aheers”), including its directors, employees, agents, and associated partners.

### **2. Eligibility**

The Competition is open to all South African residents who:

- Are 18 years or older

The following persons are not eligible to enter:

- Directors, shareholders, employees, agents, consultants of Aheers
- Supplier representatives associated with the Competition
- Immediate family members (spouses, life partners, parents, siblings, or children) of the above
- Any person entering on behalf of a business or entity

### **3. Competition Period**

Each competition will run for the period communicated in-store or through Aheers marketing channels.

Entries received after the closing date will not be considered.

### **4. How to Enter**

Participants must comply with the entry requirements communicated for each competition, which may include:

- Purchasing qualifying products
- Meeting a minimum spend requirement where necessary

- Entering via till slip, WhatsApp, or other stated methods
- Providing valid proof of purchase in the form of the associated competition slip or a till slip that lists the qualifying products.
- Writing down their full name and phone number on the till slip and placing the slip into the competition associated box.

## **5. Entry Rules**

- Each qualifying transaction/till slip may count as one entry, unless otherwise stated
- Multiple entries may be permitted
- Only cash and card purchases may qualify, unless otherwise stated
- Entries must be complete and legible
- Aheers reserves the right to verify entries and disqualify any participant suspected of fraud, tampering, or non-compliance

## **6. Prizes**

- Prizes will be communicated in-store or via Aheers marketing platforms
- Prizes are not transferable and may not be exchanged for cash or other goods/services

## **7. Winner Selection**

- Winners will be selected via a random draw or other fair method
- Draws may take place weekly, monthly, or at the end of the campaign

## **8. Winner Notification**

- Winners will be contacted using the details provided at entry
- Aheers will attempt contact for up to five (5) consecutive working days
- If a winner cannot be reached or fails to respond, an alternate winner may be selected

## **9. Publicity and Marketing**

By entering any Aheers competition, participants agree that:

- Aheers may use their name, image, and likeness for promotional purposes
- Winners may be required to pose for photographs and/or videos

- These may be shared on social media, marketing materials, and in-store platforms
- No compensation will be payable for such use.

## **10. Liability**

Aheers is not responsible for:

- Lost, damaged, or incomplete entries
- Technical failures or system errors
- Any loss, damage, or injury arising from participation or prize use

## **11. Right to Amend or Cancel**

Aheers reserves the right to amend, suspend, or terminate any competition at any time, subject to applicable law.

By entering, participants consent to the collection and processing of personal information in accordance with the Protection of Personal Information Act.
